       My name is spelled D-U-S-T-E-N.

   Q. And your -- what's your date of birth?

- 1 A. October 7th, 1981.
- 2 Q. You're 29 years old?
- 3 A. Yes, ma'am.
- 4 Q. How far did you go in school?
- 5 A. I graduated high school, 12th grade.
- 6 Q. And you're obviously in the military. What branch of
- 7 the armed services are you in?
- 8 A. I'm in the United States Army, currently right now
- 9 Naitonal Guard.
- 10 Q. And what is your rank?
- Il A. An E-4, which is a specialist.
- 12 Q. When did you originally enlist?
- 13 A. I enlisted February 14th 2008.
- 14 Q. And what missions have you completed?
- 15 A. I have went to Iraq and I did a radar mission out
- 16 there. The whole time that I was out there was eleven-and-
- 17 a-half months. In that eleven-and-a-half months I did
- 18 Operation Iraqi Freedom and Oper -- excuse me, Operation
- 19 New Dawn.
- 20 Q. And I believe you have a bronze star on your lapel ---
- 21 A. Yes, ma'am, I do.
- Q. --- for your part in those missions.
- 23 Prior to being deployed to Iraq, you were stationed in
- 24 Fort Sill, Oklahoma; is that correct?
- 25 A. That's correct.

- 1 Q. And how far away is Fort Sill from Barters --
- 2 Bartlesville, Oklahoma?
- 3 A. It's approximately four hours.
- 4 Q. How long have you known the birth mother, Christinna,
- 5 in this action?
- 6 A. Since the age of 16 is whenever I met her.
- 7 Q. And y'all were in high school together?
- 8 A. That's correct.
- 9 Q. And did you date then?
- 10 A. We dated then.
- 11 Q. And at some point did you become engaged?
- 12 A. Later on. Throughout our lives we did -- we got
- 13 engaged.
- 14 Q. Can you tell me when you became engaged?
- 15 A. It was in December of 2008.
- 16 Q. And you -- you proposed.
- 17 A. Yes, ma'am, I did.
- 18 Q. Can you tell me about that?
- 19 A. It was -- I was home on Christmas leave and I was over
- 20 visiting her. I decided that I was going to get engaged
- 21 with her because, you know, she was the love of my life at
- 22 that point in time and I was for certain that this was the
- 23 person I wanted to spend the rest of my life with.
- 24 I went and bought the ring, came back. Her best
- 25 friend was there at the time. And I told her best friend

- l about it, that I was going to do it. We both went in the
- 2 room and I got on one knee and proposed to her.

- 8 during the engagement did she ever attend any family
- 9 holidays at your parents' house or with your family?
- 10 A. Easter and Thanksgiving. Thanksgiving of 2008 and if
- 11 I'm correct Easter of 2009.
- 12 Q. Did she come to your graduation from basic training?
- 13 A. Yes, ma'am, she did.
- 14 Q. Did she go out to eat with you and your parents
- 15 afterward?
- 16 A. Yes, ma'am, we did.
- 17 Q. Did she spend time with you and your other daughter,
- 18 Kelsey?
- 19 A. Yes, ma'am, she did.
- 20 Q. Did you spend time with her and her children?
- 21 A. Yes, ma'am, I did.
- 22 Q. Can you explain to me -- explain to the Court, the
- 23 time you were engaged -- well tell me this. When did you
- 24 find out she was pregnant?
- 25 A. It was in January 2009. She called me up and told me

- 1 that -- that we were expecting a child.
- 2 Q. What was your reaction?
- A. I was very happy.
- 4 Q. Why?
- 5 A. This is the person that I loved. I was wanting to
- 6 unite my family, my daughter with her kids, and, you know,
- 7 start this family. This is the person I want to spend my
- 8 life with.
- 9 Q. Did you at any time talk about getting -- well did you
- 10 have a date set when you were engaged? Did y'all talk
- 11 about a date of marriage?
- 12 A. We talked about it. I believe we talked about like
- 13 springtime or something like that, you know, would be good
- 14 weather for the families to be there.
- 15 Q. Did y'all talk about location of the wedding?
- 16 A. I'm not for certain the location wise. I think we
- 17 mentioned Woolaroc, which is located in Bartlesville,
- 18 Oklahoma, as just an idea.
- 19 Q. And at any point when you found out she was pregnant
- 20 did you discuss getting married earlier than you originally
- 21 planned?
- 22 A. Yes, ma'am .
- 23 Q. Can you tell me about that?
- 24 A. I wanted to get married before the child was born that
- 25 way the child was not born out of wedlock.

- 1 Q. Did you want the child to have your last name?
- 2 A. Yes, ma'am, I did.
- 3 Q. And what was Christinna's reaction to that?
- 4 A. Really nothing. You know, we just discussed it, you
- 5 know, to get married earlier.
- 6 Q. Did she seem agreeable to that?
- 7 A. I'm not really sure. I want to say, yes, but I kind
- 8 of want to say something different.
- 9 Q. Well did you get married sooner than later?
- 10 A. No, ma'am, we didn't.
- ll Q. In fact at some point did she break off your
- 12 engagement?
- 13 A. Yes, ma'am.
- 14 Q. So you're in Fort Sill, which is a four-hour drive one
- 15 way from Bartlesville where Christinna was living; is that
- 16 correct?
- 17 A. Yes, ma'am.
- 18 Q. And can you tell me often that you and Christy -- this
- 19 was a situation during your dating life and your engaged
- 20 life; is that right?
- 21 A. That's correct.
- 22 Q. And how -- how often would you see one another?
- 23 A. As much as I can come home. During the holidays, like
- 24 Christmas holiday we get a 14-day pass. And -- which comes
- 25 out of our leave earnings that we acquired. I would come

- 1 home during Christmas, spend my 14 days and head back.
- 2 Being four hours away I was able to come home on the
- 3 weekends, but I didn't make the right amount of money, you
- 4 know, to be sufficient enough for me to come home, you
- 5 know, whenever I wanted to.
- 6 Q. Because how much -- how much -- I don't know how much
- 7 that gas money would cost, but I assume was a fair amount,
- 8 a fair distance.
- 9 A. It was a good distance, a fair amount.
- 10 Q. Would she sometimes try to see you on base?
- 11 A. No, ma'am.
- 12 Q. Did you talk very often with one another?
- 13 A. We talked on the phone, text messaged, Facebooked.
- 14 Q. Did you speak daily?
- 15 A. Pretty much daily we was on the phone with each other.
- 16 Q. Was there a point in time when the communication
- 17 between the two of you began to decrease?
- 18 A. It decreased after a while. I want to say around
- 19 April it started to go down.
- 20 Q. Are you talking about April of 2009 before you child
- 21 was born?
- 22 A. Yes, ma'am.
- 23 Q. Do you know -- can you -- can you explain to me the
- 24 circumstances if you know why that communication started to
- 25 decrease?

- 1 A. I really never got a straight answer on why the phones
- 2 had gone off, you know. At that point in time we did get
- 3 our mission down for Iraq so training was a must. And
- 4 whenever I got off work I was pretty tired and went home
- 5 and pretty much went straight to bed.
- 6 I tried text messaging her and stuff, you know, seeing
- 7 how her day went.
- 8 Q. Did you get a reply?
- 9 A. Sometimes.
- 10 Q. But you were saying in March -- or April, April of
- 11 2009 I think you said, that it began to decrease. Did you
- 12 call her and did she answer your phone calls?
- 13 A. Sometimes she answered. At some point it stopped
- 14 where I didn't get no answer from either text or phone
- 15 call.
- 16 Q. Did you become suspicious that she may be seeing
- 17 somebody else?
- 18 A. I did. And in the military that's very common.
- 19 Q. And as a result of your suspicion what did you do?
- 20 A. Well first I called my friends up to, you know, let's
- 21 go by and check, you know, see if there's any suspicious
- 22 cars, you know, if any of them seen her out, you know, how
- 23 things were going if they did see her.
- 24 Q. And what -- what were you told? What did you find
- 25 out?

- A. It turned out most of them really never seen her out.
- 2 They didn't see her out and about. One of my friends did
- 3 state that he drove by and said that everything looked
- 4 normal.
- 5 Q. Okay. And then what did you do?
- 6 A. I was able to actually make my way home. I want to
- 7 say it was some time in May. I was able to come home and I
- 8 get in pretty late. It was probably about 9:00 in the
- 9 evening. And I went over to my friend's house because I
- 10 figured she'd probably be at work. I did send her a
- ll message stating that I was home for the weekend. We had a
- 12 four-day pass and I wanted to see her. And I never got no
- 13 reply back on that. If I'm correct it was around like 2:00
- 14 in the morning. I was still at my friend's house. I get a
- 15 text message stating that she'd worked a 14-, 16-hour day
- 16 and she did not want to see anybody.
- 17 So I respected that. I was like, okay, you know.
- 18 O. You were her fiance?
- 19 A. Correct.
- 20 Q. And it didn't -- how long had it been, if you recall,
- 21 since you saw her last?
- 22 A. It'd been a little bit. I want to say about a month,
- 23 month and a half, possibly ---
- 24 Q. Did you find out the ---
- 25 A. --- two months.

- Q. I'm sorry. Go ahead.
- A. Possibly two months.
- 3 Q. How did that make you feel?
- 4 A. I was pretty hurt about it, you know. That, you know,
- 5 I figured, you know, you hadn't seen me in so long that she
- 6 would want to see me, you know. I'd be one of the first
- 7 persons that she would want to see, you know, if I was in
- 8 town, you know.
- 9 Q. And so that was that evening. What happened the rest
- 10 of the weekend that you were at home on leave?
- 11 A. I left and I stayed over at my friends house that
- 12 night. Waited until the next morning. I guess about noon
- 13 time I called. No answer. Sent a text message stating see
- 14 what she was doing, if she was all right. I didn't get no
- 15 reply back. The rest of the weekend went by with no -- no
- 16 communication.
- 17 So I, you know, I went by. She wasn't there. So I --
- 18 I respected it her. After that I was like, well, I'll let
- 19 her contact me, you know. Maybe something happened, unless
- 20 she just didn't want to, you know, having any communication
- 21 or having any, you know, company So I -- I, you know,
- 22 respected her on that.
- 23 Somebody happened to come around. I was headed back
- 24 to Fort Sill because I always head back a day early that
- 25 way if there's anything I need to get done at Fort Sill

- l before the next court -- work day I was ready to go.
- 2 I get half-way home to Fort Sill and I get a phone
- 3 call or a text message stating that I needed to find
- 4 someone in Lawton, Oklahoma, to be with instead of being
- 5 with her.
- 6 Q. And that was from Christinna?
- 7 A. Yes, ma'am.
- 8 Q. Did you text back?
- 9 A. I text back wanting to know what was going on and what
- 10 happened. Was there anything that I did wrong, you know,
- 11 trying to get some sort of answer. And the only answer
- 12 that I got was that I needed to find somebody else to be
- 13 with.
- 14 Q. To this day do you have any idea why she suddenly grew
- 15 distant from you and broke off this engagement?
- 16 A. No, ma'am, I don't.
- 17 Q. Did you continue to try to call her, try to contact
- 18 her?
- 19 A. I did. I had tried text messaging her several days
- 20 after that. Tried calling a couple of times and I
- 21 continued to get nothing.
- 22 Q. And then the next time that you all spoke, do you
- 23 recall when that would have been?
- 24 A. I'd say around the first week of June, second week of
- 25 June, somewhere around there, wanting to know if I wanted

- 1 to be paying child support or give my rights away.
- 2 Q. Did you receive a phone call or a text message?
- A. It was a text message.
- 4 O. From Christinna?
- 5 A. Yes, ma'am.
- 6 Q. And did you respond back to that?
- 7 A. I responded back to it stating that I really didn't
- 8 know what to do. I didn't want to sign my rights away. It
- 9 was something that, you know, any parent wouldn't want to
- 10 do. It's a hard decision.
- 11 Q. Well let me ask you, did you have any problem paying
- 12 support for this child at that point in time?
- 13 A. At that point in time I have not paid anything.
- 14 Q. No, I said did you have a problem with paying if she'd
- 15 have -- if she'd needed money could you have -- would that
- 16 have been something that you would have denied her and not
- 17 wanted to pay?
- 18 A. Money was tight at that point in time but I had no
- 19 problem, you know. I lived in the barracks. I had a meal
- 20 card to, you know, eat at the Defac there on base. So, you
- 21 know, everything was there that I needed for anything and I
- 22 had no problem, you know, if -- if needed to be to pay
- 23 child support or anything.
- 24 Q. Mm-hmm.
- 25 A. Anything that she needed.

- 1 Q. Okay. In fact you said you wanted to get married
- 2 quicker so that ---
- 3 A. Yes, ma'am.
- 4 Q. If y'all had gotten married are you aware of what
- 5 benefits she would have been entitled to and your child
- 6 would have been entitled to by virtue of your service?
- 7 A. Yes, ma'am. If we would have gotten married my pay
- 8 would have got increased. She would have been able to come
- 9 live down there on post with me, though it would have been
- 10 some time before we would have been able to get a house on
- Il post because it takes roughly about a year or more. She
- 12 would have been able to have the child there, have the
- 13 hospital. She would have been able to be seen by the
- 14 doctors there at the hospital for anything that she needed
- 15 too.
- 16 Q. And since she -- she would have been required to move,
- 17 I assume, would she have been working or would you have
- 18 been the only person working?
- 19 A. I'd have been the only person working until she
- 20 decided if she wanted to work or, you know, that's
- 21 something that we wanted to agree on.
- 22 Q. Okay. You said that she had asked you if you wanted
- 23 to sign your rights away?
- 24 A. Yes, ma'am.
- 25 Q. Why did you think she was asking you to do that?

- l A. Honestly I ---
- 2 Q. If you know.
- 3 A. Honestly I don't know. It was a big surprise to me
- 4 because, you know, the whole split, breakup, was a shock,
- 5 you know. We had a really good relationship.
- 6 Q. And at some point in this June text conversation did
- 7 you -- did you tell her that you would agree ---
- 8 A. I want to say ---
- 9 Q. --- to sign?
- 10 A. --- it was a couple of days later that, you know, I
- ll believe she sent me another text message back. I'm not for
- 12 certain, but I replied back in a text message to her
- 13 stating that I would sign my rights to her.
- 14 Q. Why did you do that?
- 15 A. In my mind I thought that if I would do that I'd be
- 16 able to give her time to think about this and possibly
- 17 maybe we would get back together and continue what we had
- 18 started.
- 19 Q. Did you have any idea that she was asking you that
- 20 because she intended to give this child up -- your child up
- 21 for adoption?
- 22 A. I had no idea that giving the child up for adoption.
- 23 I had nothing in the back of my mind thinking that even.
- 24 Q. If you had known something that you would have agreed
- 25 with?

1 A. If I knew that that's -- the adoption was going on, I

- 2 would have said no, I wanted to keep my rights. And I
- 3 would have fought then. I would have started right then
- 4 and there. I would have went to military JAG and got a
- 5 military lawyer and got started in the process of what I
- 6 needed to do.
- 7 Q. What did you think -- well what did you think the
- 8 situation of your child was as far as who was going to be
- 9 caring for the child under this scenario?
- 10 A. I -- I figured that she would be the one that would
- 11 have the child and the child would be with her and she
- 12 would be the one to be taking care of her.
- 13 Q. And what was your ultimate hope as far as an outcome?
- 14 Did you want -- you wanted to get back together?
- 15 A. I wanted to get back together very badly.
- 16 Q. And -- can you describe Christinna's personality just
- 17 a little?
- 18 A. She's very -- she was very independent, very loving
- 19 person, excellent mother, great friend. She was my perfect
- 20 idea of the person I wanted to spend the rest of my life
- 21 with.
- 22 Q. Then after your child was born -- you knew your
- 23 child's approximate date of birth; is that right?
- 24 A. When we were still engaged she told me that the child
- 25 would be born the first week of September. So I -- I knew

- 1 that the child would be born either the first week or
- 2 second week of December [sic].
- 3 Q. And where were you physically during that time period?
- 4 What were you doing?
- 5 A. Physically I was in Fort Sill, Oklahoma. At that
- 6 point in time we were training for the mission for Irag to
- 7 go down there. We had to make sure that we knew exactly
- 8 what we were doing on this piece of equipment because it
- 9 was the sole purpose of being out in Iraq. Radar is very
- 10 important. We need to know where our soldiers are at,
- 11 where the enemy's firing from. And it's very important
- 12 that we got this training.
- 13 Q. Were you -- you -- in the middle of this training were
- 14 you allowed to leave the base?
- 15 A. No, I wasn't.
- 16 Q. Oh, I'm sorry. I didn't catch this earlier. You said
- 17 the first or second -- you said December or did you say
- 18 September?
- 19 A. September.
- 20 Q. Okay. After your child was born did you make any
- 21 attempts to try to visit with Christinna or visit your
- 22 child?
- 23 A. No, I didn't. I contacted friends and family to see
- 24 if maybe they'd seen her around or about because I had made
- 25 phone calls and text messages that never got replied from

- l or back to me. I didn't know if maybe she had possibly
- 2 changed her number or moved away. I did not know at all.
- 3 Q. I'm not talking about this time period that the child
- 4 was born, but after the birth did you ever go to
- 5 Christinna's house? Did you ever come back from Fort Sill
- 6 and go to her house?
- 7 A. I came back at one point in time, went by the house
- 8 and I knocked at the door. I heard voices inside, but no
- 9 answer was made.
- 10 Q. And -- and -- can you tell me approximately what time
- 11 frame we're in now?
- 12 A. I want to say around August, first week of August
- 13 possibly.
- 14 Q. Okay. Now I asked you about after the child was born
- 15 though. The child was born in September.
- 16 A. Oh, after. I want to say that I did, but I'm not too
- 17 sure on that. I did make my way home. At that point in
- 18 time I had quite a bit of things going on in my mind at
- 19 that time.
- 20 Q. But -- okay. So my question to you, you don't know
- 21 whether -- you don't remember whether you went by her house
- 22 after September ---
- 23 A. No, ma'am, I don't.
- 24 Q. Between September and December you don't have any
- 25 recollection of whether or not you went by the house?

- 1 A. No, ma'am.
- 2 Q. When you and Christinna were speaking a little bit
- 3 more, I know that it gradually decreased, she had alleged
- 4 that you were going out in bars with your fellow, I guess,
- 5 military and did -- tell me about that. Did you ever not
- 6 answer one of her phone calls?
- 7 A. There's a possibility that I might not have answered
- 8 it, but whenever I got a hold of my phone to see if I
- 9 missed any calls, I did contact back or through a text
- 10 message back to her.
- Being in the military we have to bond with each other
- 12 because we don't know where we're going to get deployed to
- 13 and we want to know who this person is, where they come
- 14 from, how they react to things. This is the person that's
- 15 going to be watching your back overseas, so it's -- it's
- 16 very important that we do create a bond.
- 17 And the way we bond is going out and hanging out.
- 18 There were occasions that I would be out -- out at the bar,
- 19 drinking with my buddies, joking and having a good time,
- 20 possibly sitting in a barracks room, laughing it up, you
- 21 know, having a couple of beers, and just enjoying each
- 22 other, you know, talking.
- 23 Q. Well my question was, was there ever times that
- 24 Christinna called you that you didn't return her call that
- 25 night or -- that -- well that -- you may not remember, but

- 1 I mean, can you tell me what your regular practice was
- 2 then?
- 3 A. If she called, I answered. If I -- if I didn't answer
- 4 the phone I called her back or sent her a text message. So
- 5 I tried not to ignore her as much as I could.
- 6 Q. You were eventually served with some pleadings in this
- 7 action; is that correct?
- 8 A. Yes, ma'am.
- 9 Q. And you got a phone call, somebody told you to meet
- 10 them somewhere at somebody's office?
- 11 A. I got -- I got a phone call. It was -- I'm not
- 12 exactly sure on the date. It was between January 6th
- 13 through January 10th that I got a phone call from Washington
- 14 County Sheriff's Department stating that I needed to come
- 15 down and sign some papers signing my rights over to
- 16 Christinna.

Yes, ma'am. 12 Q. And this document, ---MS. JONES: Your Honor, I'd move, it's my 13 understanding this is by consent, to admit Defendant's 11. 14 THE HONORABLE MALPHRUS: Defendant's 11 is 15 16 admitted without objection; is that correct? 17 MR. GODWIN: No objection. 18 MR. LOWNDES: No objection. 19 MS. NIMMO: No objection. 20 (Whereupon, an Acceptance of Service and Answer by 21 Defendant, having been previously marked, was admitted into 22 evidence as Defendant's exhibit number 11.) 23 And according to that Acceptance of Service -- well 24 first of all, you were served the summons and complaint 25 that day?

- l A. Yes, ma'am.
- 2 Q. And then this is the instrument that purports to
- 3 consent to terminating your parental rights?
- 4 A. Yes, ma'am.
- 5 Q. And to the adoption? Is that right? Is that your
- 6 understanding?
- 7 A. To my understanding, yes. After I signed the paper is
- 8 when I found out it was an adoption. And I'm not ---
- 9 Q. Okay. Tell me about that. Tell the Court about that.
- 10 A. I looked over the papers and I don't practice law so I
- 11 don't know exactly for sure. What I should have done is
- 12 had a military lawyer with me whenever I went to sign it.
- 13 Didn't think that I needed it because I figured it was me
- 14 signing my rights over.
- 15 So I went, signed the paper, handed it back to the
- 16 gentleman. He was going to hand me the copy, my copy, and
- 17 once he got the papers he stated that she had signed her
- 18 rights over for adoption to someone else.
- I then tried to grab the paper up. He told me that I
- 20 could not grab that because it could be where I would be
- 21 going to jail if I was to do any harm to the paper.
- 22 Q. Okay. He took it?
- 23 A. He took it.
- 24 Q. What did you do as a result of that?
- 25 A. I left there, went with my parents, because I was with

- 1 them at the time, discussed with them exactly what we
- 2 needed to do and what was going on because I had six days
- 3 to deploy for Iraq. My mind was already spent on that.
- 4 Now I've got more stress coming on me about this.
- 5 The guy at the place told me that what I needed to do
- 6 was to get in contact with a lawyer. Therefore, the next

- 19 Q. Were there -- were there ever any documents sent to
- 20 you in Iraq for you to sign and send back so they could be
- 21 filed in Court?
- 22 A. No, there wasn't.
- 23 Q. When you received the paperwork in January, as you
- 24 testified the first time you ever heard about the adoption,
- 25 did you know where the child was located at that time?

SEPTEMBER 14, 2011

- At that point in time, no. I figured that she was
- still in Bartlesville. I didn't know if Christinna was
- 3 even living at the same place or not.
- When did you find out that the baby was in South 4
- Carolina? 5
- 6 A. I'm not ---
- 7 Q. If you know.
- 8 I'm not really sure.
- 9 Is it fair to say that from the time you were served
- 10 notice of the adoption, to the extent allowed by your
- 11 military service, that you have been involved in these
- 12 proceedings and have fought to gain custody of your child?
- Can you say that again? 13
- 14 From the time that you received the -- the service and
- the -- the notice of the adoption in January of 2010 -- is 15
- that right, yeah 2010 -- other than when you were 16
- 17 unavailable because you were in Iraq in the military, you
- have been actively involved in proceedings in both Oklahoma 18
- 19 and South Carolina regarding this child, correct?
- 20 A. That's correct.
- 21 And you have since January of 2010 fought to have
- 22 custody of this child placed with you, correct?
- 23 A. That is correct.
- 24 MS. NIMMO: I don't have any other questions for
- 25 this witness. Thank you.
