The organization provided counseling & services to assist parents seeking to adopt children, foreign and domestic, and provided foreign agents to escort and facilitate adoptions. The grants are for adoptions assistance to families seeking adoption and to orphanages that care for children prior to adoption in foreign countries. In 2010 the organization served 170 adoptive and birth parents, placing 70 children with adoptive families. \$3,000 was donated to assist adopting families, and \$7,375 went to foreign orphanages to assist their programs.
