And he said this way 3 Christy got full custody of the baby if anything did happen to him. 5 You knew that the baby was expected in September 2009? 6 Yeah, the first week was the only thing we knew. 7 Chrissy [sic] never contacted us and told us that 8 everything was going okay with the -- with her pregnancy or 9 anything. And I finally got her phone number, oh, shortly before 10 11 she had the baby. And we found out that she had had the 12 baby and it was about two weeks after she had delivered. And I had called her and left a message because she 13 14 wouldn't answer the phone. And I left a message and I 15 said, Chrissy [sic], this is Alice, Dusty's mom. 16 We have some gifts from the family. It was money and a 17 little blanket that I made for the baby and some little socks, and Elmo, Kissy Baby, and a rabbit we had bought the 18 baby -- or Dusty had bought the baby for Easter it was. 19 20 And I had bought the baby a little book. - 18 your house. Our Guardian ad Litem made a visit to your
- 19 house in July. And is it your understanding she'd been
- 20 involved in this case since November of 2009?
- 21 A. She said that she was -- had worked with them to do
- 22 the -- for the adoption.
- 23 Q. She told you she had worked with who?
- 24 A. With the adoptive parents.
- 25 Q. She did?

- A. Yeah, to prepare them for the adoption.
- 2 Q. Did she tell you when she did that? Meaning before --

- 3 before the baby was born?
- 4 A. Yeah, before the baby was born.
- 5 Q. What else did she tell you at her visit to your home?
- 6 A. To -- what, pertaining to my home?
- 7 Q. Any -- Yes, ma'am. There was a -- as you know we made
- 8 a motion to remove the Guardian and that was heard for a
