

## TERMINATION OF PARENTAL RIGHTS AND SURRENDER OF CUSTODY

I certify that:

1. 1. I am Ana Dominguez residing at 343 New Grant Street Wilkes Barre, PA 19702 I was born on October 1, 1990 . My social security number is 147-04-4404
2. 2. I am the biological mother of Baby boy Dominguez/Veer Singh Pannu, a baby boy born on April 9, 2014 at ~~Geisinger~~ at Geisinger Medical Center (hereinafter "the child"). I have named Manpreet Pannu as the biological father of my child.
3. I understand that under the laws of the State of New Jersey by signing this surrender, I am giving up all my parental rights, guardianship, and custody of the child in favor of Golden Cradle, an approved agency. I understand that when I sign this paper my parental rights will end and go to Golden Cradle. I do this knowingly, voluntarily, of my own free will, and intentionally. I know what I am doing and I intend to do this.
4. I understand that by this termination of my rights in favor of Golden Cradle, I will have no rights in, or control over, the child. I understand that Golden Cradle will have full authority and control over the child with the legal right to make decisions about medical, legal and social matters, including future care, education and adoption of the child. The decision power of Golden Cradle will also include the legal right of Golden Cradle to refer the child to a public or private institution or home or agency in this or any other state if required by the physical, mental or social condition of the child.
5. I am surrendering the child to Golden Cradle for purposes of adoption. I agree to the placement of the child for adoption by Golden Cradle, to such person or persons as Golden Cradle, in their sole discretion or choice, shall select.
6. I understand and recognize that under the laws of the State of New Jersey once I sign this surrender, Golden Cradle will not have to notify me of the filing of the complaint for adoption or of any court proceedings or hearing in regard to the adoption. I know that by signing this document I am voluntarily waiving and giving up my right to be notified of any legal proceedings in regard to the adoption.
7. I understand that under the laws of the State of New Jersey this surrender is valid and binding without regard to my age.

I understand that under New Jersey law this Termination of Parental Rights and Surrender is irrevocable, that is that I will not be able to change my mind. Once I sign this surrender, it is forever.

9. I understand that this Termination of Parental Rights and Surrender of Custody is governed by, and will be interpreted under the laws of the State of New Jersey.

10. I am not under the influence of alcohol, medications or illegal drugs. I am competent and fully understand this Surrender and what it means.

11. Recognizing and understanding all of the above, I freely, voluntarily, knowingly and intentionally relinquish all of my parental rights in, or guardianship or custody of the child to Golden Cradle, an approved agency.

12. I was provided with at least three (3) face-to-face counseling sessions, which provided counseling that fully explored alternative plans for the child, that is, plans other than adoption, including but not limited to temporary foster care, day care and care by relatives which counseling sessions took place on three separate days as follows:
